Syllabus: "Gender and Economics"

(a) Inhalt und Ansatz | Content and Approach

Justification: The recognition of the relevance of gender in economic development has gained momentum in recent years, with various actors showing interest in gender-related issues. Despite this, there is still a limited understanding of the gendered impacts of economic policies, programs, and projects, as gender is not mainstreamed in economic analyses. Therefore, a course on Gender and Economics for Master's students is necessary to address this gap and equip them with the knowledge and skills to design policies and programs that promote equitable and sustainable economic development.

The course aims to provide students with a comprehensive understanding of the gendered impacts of economic decisions, including the perpetuation of gender inequalities such as the gender wage gap and disparities in access to finance, education, and healthcare. Furthermore, the course will encourage self-reflection among students to recognize their gender biases and how this affects their analysis of economic issues. This awareness is crucial for students to become better at addressing gender disparities in policies and the workplace in their future roles as policymakers, economists, and business leaders.

The course also includes topics on political economy from a black and feminist perspective, intersectionality, and gender and international trade. These topics aim to broaden students' understanding of the complex and multidimensional nature of gender and economics, and how these intersect with race, ethnicity, and nationality in shaping economic opportunities and outcomes. Ultimately, the course on Gender and Economics will serve as a critical foundation for Master's students to become knowledgeable and skilled professionals in addressing gender disparities and promoting equitable and sustainable economic development.

(b) Qualifikationsziele | Learning Objectives

- 1. To equip students with the knowledge and skills to conduct gender analysis in economic decisionmaking related to policies, programs, and projects, promoting a more equitable and sustainable economic development.
- 2. To encourage self-reflection among students on their own gender biases and how this affects their analysis of economic issues, promoting a better understanding of gender disparities in policies and the workplace.
- 3. To serve as a starting point for students' further exploration and self-study of gender issues in economics. While the course covers a range of topics related to gender and economics, it cannot provide an in-depth analysis of each topic. However, the course aims to inspire students to continue learning and researching on their own, or to pursue further studies in gender and economics.
